



Sweepstakes Rules

Greater Asheville Regional Airport Authority

1. **Eligibility:** Sweepstakes are open to any legal residents of the United States, who is a person twenty-one (21) years of age or older at time of submission. Greater Asheville Regional Airport Authority (GARAA), and its parent, subsidiaries and affiliated companies, sales representatives, licensees and the advertising, fulfillment, prize sponsors, judging and promotion agencies involved in the development and administration of a sweepstakes, and each of their respective officers, directors, employees and agents (collectively, “Promotion Parties”), and their immediate family members and persons living in the same households of each (whether related or not) are not eligible to participate. Sweepstakes are subject to all applicable federal, state and local laws and is void where prohibited by law. Participation in any sweepstakes constitutes agreement to comply with these GARAA General Sweepstakes Rules.
2. **Entry:** To participate in a sweepstakes drawing, an individual must complete an entry in the following manner, and only one entry per person will be accepted, even if a sweepstakes offers multiple entry options.

vouchers or certificates. If a person has already been awarded a prize, another drawing shall take place to select a substitute prize winner. The Promotion Parties are not responsible for flight cancellations, weather conditions or accommodation requests or any other circumstance beyond its control, or for inability of winner to travel in accordance with these GARAA General Sweepstakes Rules. All other expenses not specifically mentioned herein, including, but not limited to, additional meals, gas, parking fees, insurance, tolls, beverages, activities, incidental hotel expenses, transportation, taxes and/or gratuities are the sole responsibility of the winner. The winner is responsible (at his/her expense) for ensuring that he/she has a valid required travel documentation.
