Position Summary (Primary Function)

The Airport Planning Manager will oversee management of all project activities at the airport to include coordinating and supervising engineering, architectural consultants and contractors connected with the design, construction, operation of airport facilities, projects and programs. Will review and check engineering drawings and maps for program compliance and airport requirements. Maintains and ensures that daily logs of construction activities are kept and prepares reports of activities for the FAA. Reviews tenant plans, coordinates work with other departments and outside agencies. Performs basic CAD functions in support of other department's needs.

Responsibilities (Essential Functions)

- Coordinates, supervises and implements the design and/or construction of Airport Capital improvement projects.
- Performs project management duties for design and construction activities. Manages the administrative aspects: updates schedules and monitors progress of project in meeting established schedule, performance and quality measurements.
- Coordinates and/or performs tasks related to process for bidding and contracting of services, develops cost projections, engineering specifications, project budgets, and schedules.
- Provides technical advice, information and assistance to co-workers, consultants, contractors and others regarding procedures, regulations, and standards. Organizes, prioritizes, and coordinates work activities; monitors and inspects status of work in progress and inspects completed work to ensure compliance with contracts.
- Participates in the selection of and coordinates with engineering firms in the design of Airport related projects.
- Coordinates and supervises projects during design and/or construction phases; attends/conducts progress meetings; works with consultants, contractors and work crews to resolve problems and initiate solutions. Assists with field decisions and prepares or approves change orders; monitors schedule, inspects quality of work and materials; coordinates final inspections and facilitates project acceptance.
- Responds to calls outside of normal work hours and returns to work as needed to resolve urgent problems 24/7/365.
- Prepares, receives, and/or reviews construction and engineering plans, designs, and specifications pertaining to projects and directs reviews as appropriate: performs or requests the consultant to provide modeling, testing, planning, and engineering studies in support of project analysis and design.
- Prepares and checks engineering drawings and maps. Creates drawings both manually and by Windows based PC utilizing CAD software or GIS software, and checks detailed engineering drawings and computations following general procedures. Responsible for updating facility drawings and backing-up files; developing a filing system for archiving computer generated drawings of in-house and outside generated plans.
